# Farm Credit Administration 2023 Federal Employee Viewpoint Survey

Each year, the Office of Personnel Management (OPM) conducts the Federal Employee Viewpoint Survey (FEVS) in which the Farm Credit Administration (FCA) participates. This report provides a brief summary of the 2023 results, followed by tables showing the survey responses by measure.

The 2023 survey was conducted online from May 16 to July 14, 2023. An email link to the survey was sent to all 300 eligible agency employees. This was a census survey, and 239 FCA employees responded, reflecting a 79.7% response rate. FCA's engagement index score this year is 84%, an increase of 1 percentage point from 2022.

#### The results

The agency's scores for all major indices remain higher than the average governmentwide and small agency scores. Also, our scores improved by several percentage points from last year on the following survey statements:

- Employees are protected from health and safety hazards on the job. (+9)
- Employees in my work unit consistently look for ways to improve customer service.
   (+8)
- My organization meets my accessibility needs. (+8)
- Employees in my work unit consider customer needs a top priority. (+7)

Overall, the highest positive scores were in response to the following statements:

- My supervisor holds me accountable for achieving results. (98%)
- Employees in my work unit meet the needs of our customers. (96%)
- My supervisor supports my need to balance work and other life issues. (96%)
- Employees in my work unit contribute positively to my agency's performance. (96%)
- My supervisor treats me with respect. (96%)

The survey also indicated that most FCA employees (93% or more) agreed with the following statements:

- Supervisors in my work unit support employee development.
- I know how my work relates to the agency's goals.
- The people I work with cooperate to get the job done.
- I am held accountable for the quality of work I produce.
- Employees in my work unit share job knowledge.
- My work unit has the job-relevant knowledge and skills necessary to accomplish organizational goals.
- Employees in my work unit produce high-quality work.
- My organization is successful at accomplishing its mission.

- My organization shares results (for example, town halls, email, distribution of reports) from the Federal Employee Viewpoint Survey (FEVS).
- My supervisor listens to what I have to say.
- It is important to me that my work contribute to the common good.

The table below shows how FCA's scores for major index categories compare with governmentwide and small agency scores.

The results below include response percentages for each survey item. The definitions for the Positive, Neutral, and Negative response percentages vary in the following ways across the three primary response scales used in the survey:

- **Positive**: Strongly Agree and Agree or Always and Most of the time or Very Good and Good or Very Satisfied and Satisfied
- **Neutral**: Neither Agree nor Disagree or Sometimes or Fair or Neither Satisfied nor Dissatisfied
- **Negative**: Disagree and Strongly Disagree or Rarely and Never or Poor and Very Poor or Dissatisfied and Very Dissatisfied
